WHEREAS, *I*, the said *Alice Leona Summey*

in and by *my* *self* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of

Three Thousand, Five Hundred and no/100 (\$3,500.00) Dollars,

to be paid on or before the date when the *30* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full;

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

and in Greenville Township, being known and designated as Lot no. 7 as shown on plat of the property of H. J. Martin recorded in the R. M. C. office for Greenville County in Plat Book "H", page 139 and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on Berbeley avenue, joint corner of Lots 7 and 8, and running thence with line of Lot no. 8, N. 20-21 W. 196.7 feet to an iron pin, joint corner of Lots 6, 7 and 8; thence with line of Lot no. 6 N. 58-00 E. 71.3 feet to an iron pin on an alley; thence S. 29-01 E. 206 feet to an iron pin on Berbeley avenue; thence with said avenue S. 65-10 W. 65.9 feet to the point of beginning.
