WHEREAS, I, the said George D. Davis,

SEND GREETINGS:

in and by my certain promissory note in writing, of even date with these presents well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Twenty Five Hundred (\$2500.00)

Dollars,

to be paid on or before the date when the Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if

In Greenville Township, lying and being in the Subdivision of Eastover (near the City of Greenville) and being part of Lot No. 29 and shown on plat of said subdivision of Eastover recorded in R. M. C. Office for Greenville County in Plat Book "F", at page 42 and being more fully described as follows:

Beginning at an iron pin 100 feet from an iron pin at joint corner of Lots 28 and 29 on Maco Street and running thence with Maco Street, S. 36-10 E. 100 to an iron pin; thence S. 53-35 W. 107 feet to an iron pin; thence N. 25-40 W. 103 feet to an iron pin; thence N. 54-46 E. 88 feet to the point of beginning.
