WHEREAS, I, A. M. Leasley, the said A. M. Leasley SEND GREETINGS:

All that certain piece, parcel, lot or tract of land located in Greenville Township, Ward 4, City of Greenville, known as lot #18, Oakland Heights property of W. B. Cleveland, plat recorded in Plat Book 6, page 147, described as follows:

Beginning at an iron pin on north side of Lois St., joint corner lots nos 17 and 18 and running thence with line of lot no 17 N. 33-49 E. 129.5 feet to an iron pin, joint rear corner lots 12 and 18 and running thence with line of lot 12 S. 64-34 E. 53.5 feet to an iron pin, thence S. 32-34 W. 131.4 feet to an iron pin on Lois St; thence with Lois St. N. 62-19 W. 50 feet to point of beginning.
