I, State Robbs Bass,

SEND GREETINGS:

WHEREAS, *I*, the said *State Robbs Bass*

in and by *my* certain promissory note in writing, of even date with these presents *and* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Two Thousand Five Hundred and no/100* Dollars, to be paid on or before the date when the *42nd* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *I* fail to pay said interest or comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *State Robbs Bass*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to *me*, the said

State Robbs Bass, the receipt thereof is hereby acknowledged have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina

in Greenville Township, near the corporate limits of the City of Greenville, near the Laurens Road on the west side of *W. Adams Avenue*, and being known and designated as Lot # 84 of Glen Grove Park, as shown by subdivision and plat of same made by *R. E. Darter, Engineer*, in May 1924, said plat being of record in the *72nd* Office for Greenville County in *Book "I"* at page *235* and having the following wells and bounds and course and distance, to-wit:

Beginning at a point on the west side of *W. Adams Avenue* at corner of lot # 85 and running thence along the line of said lot # 85 *W. 150.2* feet to corner of Lot # 96; thence along the rear line of Lot # 96 *S. 15-48 W. 58.5* feet to corner of lots # 97 and 84; thence along the line of Lot # 83 *S. 74-12 E. 150* feet to point in the line of *W. Adams Avenue*; thence along the line of said Avenue *N. 15-48 E. 50* feet to the beginning corner.

This is the same lot of land conveyed to me by the American Building and Loan Association by its deed of even date and the within mortgage is given to secure the balance of the purchase price.
