*situate, lying and being joint without the corporate limits of the City of Greenville, being known and designated as Lot # 39 of Glenn Green, as shown on plat recorded in the P. M. C. office for Greenville County in Plat Book "F", page 233, and having, according to said plat, the following metes and bounds, to-wit: -*

*Beginning at a point on the East side of Underwood Avenue, joint corner of Lots Nos. 39 and 40 and running thence with the joint line of said Lots, S. 74-12 E. 150 feet to a point, joint corner of Lots Nos. 39, 40, 13 and 14; thence with the joint line of Lots Nos. 39 and 14, N. 15-48 E. 50 feet to a point, joint corner of Lots Nos. 38, 39, 14 and 15; thence with the joint line of Lots Nos. 38 and 39, N. 74-12 W. 150 feet to a point on the East side of Underwood Avenue; thence with the East side of said Underwood Avenue, S. 15-48 W. 50 feet to the point of beginning.*
