All that certain piece, parcel or lot of land with the buildings and improvements thereon, situated on the south side of Jindal Avenue in the City of Greenville, County of Greenville, State of South Carolina known as Lot no. 10 on plat of Crescent Terrace, and having, according to said plat, which is recorded in the R. M. C. office for Greenville County, S. C., in Plat Book E, page 137, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Jindal Avenue at the joint corner of Lots 9 and 10, and running thence with the line of said lots S. 00-53 E. 200 feet to an iron pin; thence N. 89-07 E. 67 feet to an iron pin at the rear corner of Lots 10 and 11, thence with the joint line of the last mentioned lots N. 00-53 W. 200 feet to an iron pin on the south side of Jindal Avenue; thence along the south side of said Jindal Avenue S. 89-07 W. 67 feet to the beginning corner.
