Just outside the corporate limits of the City of Greenville and being known and designated as Lots Nos. 16 and 17 of Block F. on revised plat of Property of Lucy L. Hindman, which is recorded in office of R. M. C. for Greenville County in Plat Book G, at Page 208, and having the following metes and bounds, to-wit: Beginning at an iron pin at the S.W. corner of North Main Street and Fairview Avenue and running thence along Southern side of Fairview Avenue N. 66-30 W. 190 ft. to an iron pin; thence S. 14-47 W. 155 feet to an alley; thence along said alley S 66-30 E. 190 feet to an iron pin on Western side of North Main Street; thence along Western side of North Main Street; N. 14-47 E. 155 feet to the beginning corner.
