Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit: ~~the Greenville Township~~ known and designated as Lots nos 228 & 229 Park as shown on plat recorded in the R. M.C. Office for Greenville County, and having the following metes and bounds, to wit:

Beginning at a stake on the northern side of Byrd Boulevard, point corner of Lots nos 228 and 229, and running thence with joint line of said lots N. 29-33 E. 193.5 feet to a stake in line of Lot no 235, thence with line of that lot N. 57-40 W. 75.08 feet to a stake, corner Lot no 227, thence with line of that lot S. 29-32 W. 197 feet to a stake on Byrd Boulevard, thence with said Byrd Boulevard S. 60-28 E. 75 feet to the beginning corner.

Also: All that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to wit: ~~the Greenville Township~~, and being a part of what is known as City View Land Company's plat of which is recorded in Plat Book A, pages 460 and 461, and being known and designated as Lot no 55 of block B, on said plat, said lot having a frontage of 50 feet on the east side of Henderson Street, running thence back in parallel lines ~~at right angles~~ of 100 feet to a ten-foot alley.
