

AGREEMENT FOR EXTENSION OF LOAN NO. 2008186

WHEREAS, There now remains unpaid on a certain note executed and delivered by Essie G. Hester

WHEREAS, Title to the mortgaged premises is now vested in Essie G. Hester

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Essie G. Hester and H. M. Hester

hereby agree to pay the principal sum remaining due as aforesaid as follows:

- \$130.00 on July 25, 1932;
- \$130.00 on July 25, 1933;
- \$130.00 on July 25, 1934;
- \$130.00 on July 25, 1935;
- \$130.00 on July 25, 1936;
- \$130.00 on January 25, 1933;
- \$130.00 on January 25, 1934;
- \$130.00 on January 25, 1935;
- \$130.00 on January 25, 1936;
- and \$4,030 on January 25, 1937.

with interest thereon from January 25, 1932, to January 25, 1937, at the rate of five & one-half per cent. per annum, payable semi- annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of this note in sums of \$100.00 or multiples thereof on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
