

AGREEMENT FOR EXTENSION OF LOAN NO. 202233

WHEREAS, There now remains unpaid on a certain note executed and delivered by R. L. Garrison and L. E. Garrison

to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated February 5th, 1927, recorded in said County on February 11th, 1927, in Volume Book 172 of on Page 59, the sum of

Three thousand and no/100 Dollars, with interest from February 5th, 1932, and, WHEREAS, Title to the mortgaged premises is now vested in R. L. Garrison and L. E. Garrison

subject to said mortgage, and, WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said R. L. Garrison and L. E. Garrison

hereby agree to pay the principal sum remaining due as aforesaid as follows: The principal sum of Three thousand (\$3,000.00) Dollars, being payable in annual installments as follows, viz: Beginning on the fifth day of February, 1933, and on the same day in each succeeding year thereafter the sum of \$100.00, and the balance of said principal sum being payable on the fifth day of February, 1937.

with interest thereon from February 5th, 1932, to, 19, at the rate of six per cent. per annum, payable annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments of \$100.00 or any multiple thereof of the principal sum of said note on any interest maturity date, and the amount so paid shall be credited.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
