

AGREEMENT FOR EXTENSION OF LOAN NO. 85585

WHEREAS, There now remains unpaid on a certain note executed and delivered by W. N. Watson

hereby agree to to pay the principal sum remaining due as aforesaid as follows:
\$250.00 on October 26, 1932, \$250.00 on April 26, 1933, \$250.00 on October 26, 1933, \$250.00 on April 26, 1934, \$250.00 on October 26, 1934, \$250.00 on April 26, 1935, \$250.00 on October 26, 1935, \$250.00 on April 26, 1936, \$250.00 on October 26, 1936, and \$9,600.00 on April 26, 1937.

with interest thereon from April 26, 1932, to April 26, 1937, at the rate of 5 1/2 % per cent. per annum, payable semi annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of this note in sums of \$100.00 or multiples thereof on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
