

AGREEMENT FOR EXTENSION OF LOAN NO. 210749

WHEREAS, There now remains unpaid on a certain note executed and delivered by O. Mills Goodlett

to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated May 17, 1927, recorded in said County on May 17, 1927, in Volume 172 of Mortgages on Page 35, the sum of Four Thousand (\$4000.00) Dollars, with interest from May 17, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in O. Mills Goodlett

subject to said mortgage, and, WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said O. Mills Goodlett

hereby agree to pay the principal sum remaining due as aforesaid as follows: \$100.00 on November 17, 1932; \$100.00 on May 17, 1933; \$100.00 on November 17, 1933; \$100.00 on May 17, 1934; \$100.00 on November 17, 1934; \$100.00 on May 17, 1935; \$100.00 on November 17, 1935; \$100.00 on May 17, 1936; \$100.00 on November 17, 1936 and \$3100.00 on May 17, 1937

with interest thereon from May 17, 1932, to May 17, 1937, at the rate of Five and one-half per cent. per annum, payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE: Privilege is given to make additional payments on the principal sum of this note in sums of \$100 or multiples thereof, on any interest maturity date.

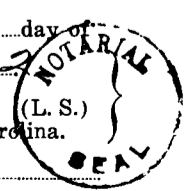
And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
