

AGREEMENT FOR EXTENSION OF LOAN NO. 212549

WHEREAS, There now remains unpaid on a certain note executed and delivered by

First Baptist Church of Greenville S.C.

to

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County,

South Carolina, dated June 20, 1927, recorded in said County on June 20, 1927, in Volume 194 of Mortgages on Page 195, the sum of Eleven Thousand Two Hundred (\$11,200.00) Dollars, with interest from June 20, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in First Baptist Church of Greenville, S.C.

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said First Baptist Church of Greenville S.C.

hereby agree to pay the principal sum remaining due as aforesaid as follows:

- \$168.00 on March 20, 1933;
- \$168.00 on September 20, 1933;
- \$168.00 on March 20, 1934;
- \$168.00 on September 20, 1934;
- \$168.00 on March 20, 1935;
- \$168.00 on September 20, 1935;
- \$168.00 on March 20, 1936;
- \$168.00 on September 20, 1936;
- \$168.00 on March 20, 1937;
- \$168.00 on December 20, 1932;
- \$168.00 on June 20, 1933;
- \$168.00 on December 20, 1933;
- \$168.00 on June 20, 1934;
- \$168.00 on December 20, 1934;
- \$168.00 on June 20, 1935;
- \$168.00 on December 20, 1935;
- \$168.00 on June 20, 1936;
- \$168.00 on December 20, 1936;
- \$8007.00 on June 20, 1937, one half

with interest thereon from June 20, 1932, to June 20, 1937, at the rate of five and one half per cent. per annum, payable quarterly; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sums of One Hundred (\$100.00) Dollars or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.

In Witness whereof First Baptist Church of Greenville S.C. by virtue of the authority contained in a resolution passed at a regular meeting of its members held on July 3, 1932, has caused this deed to be signed in its name and sealed with its seal, by the Chairman of the Finance Committee and the Treasurer of said church at Greenville S.C. this 8th day of July, 1932.

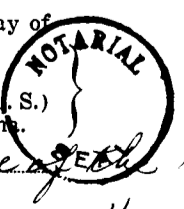
