

AGREEMENT FOR EXTENSION OF LOAN NO. 218271

WHEREAS, There now remains unpaid on a certain note executed and delivered by Helen B. Black

to The Prudential Insurance Company of America, secured by a Mortgage upon real estate in Greenville County,

South Carolina, dated September 8, 1932, recorded in said County on September 8, 1932, in Volume 172 of Mortgages, on Page 37, the sum of Sixty Four Hundred (6,400.00) Dollars, with interest from September 8, 1932 and,

WHEREAS, Title to the mortgaged premises is now vested in Helen B. Black

subject to said Mortgage, and, WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Helen B. Black and J. M. Black

hereby agree to pay the principal sum remaining due as aforesaid as follows: 160.00 on March 8, 1933; 160.00 on September 8, 1933; 160.00 on March 8, 1934; 160.00 on September 8, 1934; 160.00 on March 8, 1935; 160.00 on September 8, 1935; 160.00 on March 8, 1936; 160.00 on September 8, 1936; 160.00 on March 8, 1937; 4,960.00 on September 8, 1937;

with interest thereon from September 8, 1932 to September 8, 1937, at the rate of five and one-half per cent. per annum payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sum of 100.00, or multiples thereof, on any future maturity date.

And the parties to this agreement hereby consent to said extension and agree that said Mortgage shall continue a first lien upon said premises, and that said note and Mortgage and all their covenants and conditions shall remain in force except as herein modified.
