

AGREEMENT FOR EXTENSION OF LOAN NO. 92991

WHEREAS, There now remains unpaid on a certain note executed and delivered by H. H. Holcombe

to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, S.C., dated October 30, 1922, recorded in said County on November 14, 1922 in Volume 123 of Mortgages on Page 222, the sum of Twenty-two Hundred (\$2200.00) Dollars, with interest from October 30, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in H. H. Holcombe

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said H. H. Holcombe

hereby agrees to pay the principal sum remaining due as aforesaid as follows:

- \$50.00 April 30, 1934;
- \$50.00 April 30, 1935;
- \$50.00 April 30, 1936;
- \$50.00 April 30, 1937;
- \$50.00 October 30, 1933;
- \$50.00 October 30, 1934;
- \$50.00 October 30, 1935;
- \$50.00 October 30, 1936;
- \$1750.00 October 30, 1937.

with interest thereon from October 30, 1932, to October 30, 1937, at the rate of six per cent. per annum, payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of this note in sums of \$100.00 or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
