

AGREEMENT FOR EXTENSION OF LOAN NO. 22,5895

WHEREAS, There now remains unpaid on a certain note executed and delivered by Aileen P. Oeland

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County,  
dated December 14, 1927, recorded in said County on December 14, 1927,  
in Volume 172 of Mortgages on Page 38, the sum of Twenty-five  
Hundred (\$2,500.00) Dollars, with interest from December 14, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in Aileen P. Oeland

subject to said mortgage, and,  
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Aileen P. Oeland and husband,  
Paul J. Oeland

hereby agree to pay the principal sum remaining due as aforesaid as follows:  
The sum of Thirty-one & 25/100 (\$31.25) Dollars on March 14, 1933, and  
quarterly payments of Thirty-one & 25/100 (\$31.25) Dollars on the 14th day of  
each and every June, September, December and March  
hereafter during the life of this agreement, and the bal-  
ance of the principal on the 14th day of December, 1937.

with interest thereon from December 14, 1932, to December 14, 1937, at the rate of six (6%) per cent. per annum,  
payable quarterly annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on  
the principal sum of said note in sums of One Hun-  
dred (\$100.00) Dollars, or multiples thereof, on any interest  
maturity date

And the parties to this agreement hereby consent to said extension and agree that said mortgage  
shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force  
except as herein modified.
