

AGREEMENT FOR EXTENSION OF LOAN NO. 231441

WHEREAS, There now remains unpaid on a certain note executed and delivered by *H. D. Grant and D. D. Grant*

to
The Prudential Insurance Company of America, secured by a *Mortgage* upon real estate in *Greenville* County, *South Carolina*, dated *February 26, 1933*, recorded in said County on *February 28, 1933* in Volume *172* of *Mortgages* on Page *40*, the sum of *Six Thousand* (*6,000.00*) Dollars, with interest from *February 26, 1933*, and,

WHEREAS, Title to the mortgaged premises is now vested in *H. D. Grant*

subject to said *Mortgage*, and,
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said *H. D. Grant*

hereby agree to pay the principal sum remaining due as aforesaid as follows:

- 187.50 on Aug. 26, 1934; 187.50 on Feb. 26, 1935;*
- 187.50 on Aug. 26, 1935; 187.50 on Feb. 26, 1936;*
- 187.50 on Aug. 26, 1936; 187.50 on Feb. 26, 1937;*
- 187.50 on Aug. 26, 1937; and \$4312.50 on Feb. 26, 1938.*

with interest thereon from *February 26, 1933* to *February 26, 1938* at the rate of *Six* per cent. per annum, payable *Semi-* annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sum of \$100.00 or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said *Mortgage* shall continue a first lien upon said premises, and that said note and *Mortgage* and all their covenants and conditions shall remain in force except as herein modified.
