

AGREEMENT FOR EXTENSION OF LOAN NO. 232367

WHEREAS, There now remains unpaid on a certain note executed and delivered by I. L. Donkle

to _____
The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated March 13, 1928, recorded in said County on March 13, 1928, in Volume 172 of mortgages on Page 44, the sum of Seventy-Six Hundred (\$7,600.00) Dollars, with interest from March 13, 1933, and,

WHEREAS, Title to the mortgaged premises is now vested in I. L. Donkle

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said I. L. Donkle

hereby agree to pay the principal sum remaining due as aforesaid as follows: \$100.00 on June 13, 1933, and quarterly payments of \$100.00 on the 13th day of each and every September, December, March and June thereafter during the life of this agreement, and the balance of the principal on the 13th day of March 1938;

with interest thereon from March 13, 1933 to March 13, 1938, at the rate of Six (6%) per cent. per annum, payable quarterly, annually, and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of said note in sums of \$100.00, or multiples thereof, on any interest maturity date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.

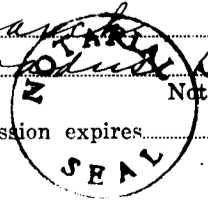
