

AGREEMENT FOR EXTENSION OF LOAN NO. 165903

WHEREAS, There now remains unpaid on a certain note executed and delivered by

Waymon Union

to

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated December 16th, 1925, recorded in said County on

in Volume 171 of on Page 127 the sum of Thirteen Hundred and no Dollars, with interest from November 1st, 1932, and,

WHEREAS, Title to the mortgaged premises is now vested in

Waymon Union

subject to said mortgage, and

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said

Waymon Union

hereby agree to pay the principal sum remaining due as aforesaid as follows:

The Principal sum of Thirteen Hundred (\$1300.00) Dollars, being payable in monthly instalments as follows: Beginning on the first day of November, 1933, and on the same day in each succeeding year thereafter, the sum of \$100.00 and the balance of said principal being payable on the first day of November 1937

with interest thereon from November 1st 1932 to 1937, at the rate of six (6%) per cent. per annum, payable annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

(Privilege) is given to make additional payments of \$100.00 or any multiple thereof of the principal and of said note to pay interest in maturity date, and amount so paid shall be credited

And the parties to this agreement hereby consent to said extension and agree that said mortgage and all their covenants and conditions shall remain in force except as herein modified.
