

AGREEMENT FOR MONTHLY INSTALMENT EXTENSION OF LOAN NO. U-239692

WHEREAS, There remains unpaid on a certain note executed and delivered to The Prudential Insurance Company of America by

H. L. Dawes

secured by a mortgage upon real estate in Greenville County, South Carolina dated June 8, 1928, and filed for record in said County on June 9, 1928, in Volume 171 of mortgages on Page 53.

the sum of Twenty seven hundred Eighty Two and 50/100 (\$2782.50) Dollars, with interest from June 1st, 1933, and,

WHEREAS, Title to the mortgaged premises is now vested in H. L. Dawes subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said H. L. Dawes (unmarried)

hereby agree s to pay the principal sum remaining due as aforesaid as follows:

On the first day of each month, beginning on the first day of July, 1933 the sum of Seventeen and 50/100 (\$17.50) Dollars, to be applied on the principal of said amount due on said note, and also, at the same times, interest at the rate of Six (6%) per cent. per annum on the balances of said principal remaining due thereon on the said first day of each month, and on the first day of June, 1938, the balance of said principal sum with interest thereon; and with interest after maturity as set forth in said note. Privilege is given to make additional payments on account of the principal sum of said note on the first day of any month. Such payments shall be in multiples of the monthly principal installment herein provided for.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
