

AGREEMENT FOR MONTHLY INSTALMENT EXTENSION OF LOAN NO. 302578-1

WHEREAS, There remains unpaid on a certain note executed and delivered to The Prudential Insurance Company of America by

Mary H. McKinney

secured by a mortgage upon real estate in Greenville County, South Carolina dated December 23, 1932, and filed for record in said County on December 26, 1932, in Volume 220 of Mortgages on Page 7 the sum of Thirtyfive Hundred and 00/100 (\$3500.00) Dollars, with interest from December 1, 1935, and,

WHEREAS, Title to the mortgaged premises is now vested in Mary H. McKinney subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said Mary H. McKinney and Spart J. McKinney hereby agree to pay the principal sum remaining due as aforesaid as follows:

On the first day of each month, beginning on the first day of January, 1936, the sum of Twentyfive and 00/100 \$25.00 Dollars, to be applied on the principal of said amount due on said note, and also, at the same times, interest at the rate of 5 1/2 per cent. per annum on the balances of said principal remaining due thereon on the said first day of each month, and on the first day of December, 1945, the balance of said principal sum with interest thereon; and with interest after maturity as set forth in said note. Privilege is given to make additional payments on account of the principal sum of said note on the first day of any month. Such payments shall be in multiples of the monthly principal installment herein provided for.

Such principal payments, including the obligatory monthly principal payments called for by the terms of this note, shall not exceed one-fifth of the original principal sum of this note during ^{any} one-year period beginning at an anniversary of this note

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
