SEND GREETING:

WHEREAS, I, the said (Mrs.) Addie P. Rollins,

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of Eight Hundred and Fifty and no/100 (\$850.00) Dollars,

to be paid on or before the date when the 56' Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of SEVEN per cent. per annum, payable weekly on or before Saturday night of each and every week
