WHEREAS, *J*, the said *Ella S. Sadler*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of *Five Hundred and no/100 (\$500.00)* Dollars,

as follows: *Greenville, known as Lot no. 2 only plat of property of W. H. Talley and O. M. Nace as recorded in Plat Book "S," Page 162, and bounds, to-wit:*

Beginning at a point on the *70* feet from the north east corner of *Elm Street* 66 feet from the north east corner of *Elm Street* and Otis Street, and running thence parallel with Otis Street *N. 72 E. 117 feet; thence N. 18 W. 60 feet; thence S 72 W. 117 feet to iron pin on Elm Street; thence with Elm Street S 18 E. 60 feet to beginning corner.*
