money loaned this day, with interest thereon from this date at the rate of eight per cent. per annum, payable weekly, the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part ~~all that certain piece, parcel and lot of land lying in Greenville County, in the State of South Carolina, as follows to wit:~~

"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the northwest side of West Prentiss avenue, and being known and designated as Lot No. 10 of Block "G", as shown on plat of the property of O. P. Mills as recorded in the R. M. C. office for Greenville County in Plat Book F, page 171, and having, according to said plat the following metes and bounds:

"Beginning at an iron pin 248 feet west from the north west intersection of Mission Street and West Prentiss Avenue, joint corner of Lots 8 and 10, and running thence along the joint line of said lots N. 44-33 W. 180 feet to an iron pin on a 16-foot alley; thence along said alley S. 45-27 W. 62 feet to an iron pin, joint rear corner of Lots 10 and 12; thence along the joint line of said lots S. 44-33 E. 180 feet to an iron pin on northwest side of West Prentiss Avenue; thence along said West Prentiss avenue, N. 45-27 E. 62 feet to the beginning corner."
