Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land, lying in Greenville County, in the State aforesaid, ~~as follows to-wit:~~

in Greenville Township, fronting on Traction Street ninety (90) feet, and running back a depth of ~~one hundred and fifty~~ ^{one hundred and forty} (150) feet, being Lot No. ~~Twelve~~ ^{Eleven} (11) in Block "B" according to plat of Melville Land Company, and Lot No. ~~eleven~~ ^{twelve} (12) in Block "B", according to said plat, excepting ten (10) foot strip conveyed to H. M. Thompson by J. W. Godfrey (see Deed Book 9, page 314), a plat of said land being recorded in the R. M. C. Office for Greenville County in Plat Book A, page 97, said lots having the following metes and bounds, to-wit:

Beginning on Traction Street, corner of lots 13 and 12, and running thence with Traction Street N. 46-15 W. 90 feet to corner of lots 11 and 10; thence N. 43-45 E. 150 feet; thence S. 46-15 W. 90 feet to corner of lots 12 and 13; thence with the joint line of Lots 12 and 13, S. 43-45 W. 150 feet to the beginning corner, being all of Lot No. ~~12~~ ¹¹ in Block "B", and all of Lot No. 11 in Block "B", excepting a 10-foot strip conveyed to H.
