all that tract or lot of land in Township, Greenville County, State of South Carolina.

All that certain piece, parcel or lot of land situate, lying and being in the city and county of Greenville, State of South Carolina, on the west side of Houston Street, and known and designated as lot No. 8 of Block "G" as shown by plat recorded in the R. M. C. office for Greenville County in Plat Book "E" at Page 41, and having according to said plat the following courses and distances, to-wit:

Beginning at an iron pin, South western intersection of Houston Street and Rose Avenue and running thence with Rose Avenue S. 88-00 W. 137.6 feet to an iron pin, corner of lot no. 7; thence with the line of lot no. 7 approximately S 2-0 E. 60 feet to an iron pin corner of lot no. 9; thence with line of lot no. 9 N. 88 E. 133.4 feet to an iron pin on Houston Street; thence with said street N. 2-0 E. 60.1 feet to the beginning corner.
