in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Kittie M. Albertson as Executrix of the will of John Albertson, all my right, title and interest in and to Greenville Township, Greenville County, State of South Carolina.

In Ward One of the City of Greenville and having the following metes and bounds, to-wit: Beginning at an iron pipe on the north side of Marsailles Street, corner of Marian Cherry property; thence along said Marian Cherry's line, N. 100 E. 65 feet to an iron pipe; thence along rear line along property of J. J. Fields, S. 74-06 E. 50 feet to an iron pipe; thence along same property S. 10-0 N. 65 feet to an iron pipe on the north side of Marsailles Street; thence along the north side of Marsailles Street N. 74-06 N. 50 feet to the point of beginning. Being the same lot of land conveyed to John Albertson by J. M. Wells by deed dated October 17, 1936 and recorded in Deed Book Vol. 187 at page 373

also, all that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina in the City of Greenville being known as Lot No. 1 according to a plat and survey of P. E. Dalton, plat recorded in Plat Book "F" at page 69 in P. M. C. Office, and having the following metes and bounds to-wit: Beginning at the northeast corner of Balkoun Street and Ware Street and running thence with Balkoun Street N. 71 E. 60 feet, thence N. 19 N. 115 feet, thence S. 19 N. 60 feet to Ware Street; thence with Ware Street S. 19 E. 115 feet to the beginning corner. Being the same lot of land conveyed to John Albertson by Robert M. Bartel by deed dated June 12, 1935 and recorded in Deed Book, Vol. 181, at page 339.
