Whereas, *I* the said *Arch Mahaffey* SEND GREENING:

in and by *my* certain *promissory* note in writing, of even date with these presents, *am* well and truly indebted to *Minnie D. Mahaffey*

in the full and just sum of *Five thousand and 94 3/4 Dollars (\$5,000.00)* Dollars to be paid *Two years after date 9 June*

with interest thereon from *date satisfied June* at the rate of *8* per cent. per annum, to be computed and paid *Annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent (10%)* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

Mahaffey* according to the terms of said note, and also in consideration of the further sum of *Three* Dollars, to *the said Arch Mahaffey* in hand well and truly paid by the said *Minnie D. Mahaffey*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said *Minnie D. Mahaffey, her heirs and assigns:*

All that piece, parcel or lot of land situated in Ward One in the City of Greenville, State and County aforesaid and having the following notes and bounds, viz: beginning at a stake on the south side of Boncombe St. 145 feet from the center of Broad St. thence along Boncombe St. 63 1/2 feet to an iron corner of Carlisle property, thence 88-23 to the right 66 3/4 feet to an iron pin, thence 91-37 to the right 66 3/4 feet to an iron pin, thence 88-23 to the right 66 3/4 feet to starting point. This being the same property sold to me by Eliza Powell.
