SEND GREETING:

Whereas, *J* the said *Dr. J. C. Stone*

in and by *my* certain *promissory*

these presents, *am* well and truly indebted to *C. S. Maree*

in the full and just sum of *Five Thousand and 200/100* Dollars
to be paid *three (3) years after date*

with interest thereon from *date*
at the rate of *8* per cent. per annum, to be computed and paid

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose

this mortgage; said note further providing for an attorney's fee of *ten per cent* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That *J*, the said *Dr. J. C. Stone*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *C. S. Maree*

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *me* the said *Dr. J. C. Stone*

in hand well and truly paid by the said *C. S. Maree*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

C. S. Maree, his heirs and assigns forever;
All that certain piece, parcel, part and lot of land, situate, lying and being in the County and State aforesaid, in part one of the City of Greenville, on the north side of Craft Street, and described as follows, to wit:

Beginning at an iron pin on the north side of Craft Street, a distance of 104 - 2/5 feet west of the Northwest Corner of Craft and Town Streets, and running thence N. 1 - 41 E. 200 feet to an iron pin; thence N. 83 - 13 W. 52 feet to an iron pin; thence S. 1 - 41 W. 200 feet to an iron pin on the north side of Craft Street; thence with Craft Street S. 83 - 13 E. 52 feet to the beginning corner, and being known and designated as part of Lots Nos. 38 and 40 of Section "B" of a plat of Stone Land Company, said plat recorded in Plat Book A, page 337-345, and being the same conveyed to me by Lydia Stone.
