until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto made, will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

J. L. Smith,
all that certain piece, parcel or lot of land situate in *Georgetown* Township, County and State aforesaid, located on the west side of *Maple* and on the North side of *Trade* Streets in the town of *Simpsonville*, adjoining lands of *J. A. Crisp* and others, containing *4346* sq. yds. more or less and being the same lot of land *the day* conveyed to me by *A. G. Huff* deed not yet recorded, also the same tract conveyed to said *A.
