Seventy five (\$75.00) Dollars on May 15th, 1944; Seventy five (\$75.00) Dollars on August 15th, 1944 and the unpaid principal balance of Three Thousand and Seventy five (\$3,075.00) Dollars on November 15th, 1944, with the privilege of anti-icipating any or all of the unpaid balance in multiples of \$100 on any interest paying date.*

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *2.00* besides all cost and expenses of collection, to be added to the amount due on the said note and to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney in legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto hereunto more fully appear.

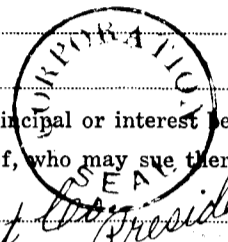
