until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of 10.00

besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, described as follows:

Beginning at an iron pin on the east side of Palmetto Avenue 318.6 feet from the intersection of Palmetto Avenue and Haynie Street, joint corner of lots 77 and 78, and running thence with line of lot no. 78 N. 79 E. 87 feet to an iron pin on Chapin Avenue, thence with Chapin Avenue S. 14-10 E. 50 ft. to an iron pin joint rear corner of lots nos. 76 and 77, thence with line of lot no. 76 S. 79 20' 40" E. 50 feet to an iron pin on Palmetto Avenue, thence with Palmetto Avenue N. 11 50' 50" E. 50 feet to the point of beginning, being same land conveyed to Walter Thompson and Bordie McKinney Thompson by Minnie Hunt, August 13, 1921 by deed recorded in Deed Book 73, page 138, R.
