*Floyd Carey, Evelyn E. Johnson* in and by *a* certain *professionary* note in writing, of  
even date with these presents, well and truly indebted to

in the full and just sum of *Nine hundred*  
Dollars, to be paid *in three annual installments of three hun-*
