with interest on principal from *November 10, 1934* at *8%* *None*

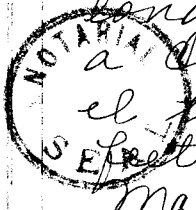
GIVEN under the Hand and Seal of the undersigned this *27th* day of *December*, 19 *34* *E. H. Henley* (L. S.)
