Beginning at a point on the southwest side of Highland Drive, which point is 11.2 feet southeast of the joint front corner of Lots nos. 50 and 51, and running thence S. 48-50 20. 192.1 feet; thence S. 41-10 E. 161.5 feet to point in rear line of Lot no. 53; thence N. 48-50 E. 192.1 feet to point on southwest side of Highland Drive; thence with Highland Drive N. 41-10 20. 161.3 feet to the beginning corner.
