these presents, wall and truly indebted to *J. W. Norwood, Trustee* note in writing, of even date with

in the full and just sum of *\$1,000.00* Dollars

to be paid: in *one year* interest *at the rate of 10% per annum* said note to be paid each

year, with interest thereon from the date *of April 1st, 1933*

at the rate of *10% per annum*, to be computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent.*, besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

according to the terms of said note, and also in consideration of the further sum

of Three Dollars, to the said *W. E. Chaudler*,

in hand well and truly paid by the said *J. W. Norwood, Trustee*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

J. W. Norwood, Trustee, All that tract or parcel of land, situated in the County of Greenville, State aforesaid, and described as follows: Beginning on the south side of Randall Street, and having the following metes and bounds: Beginning at a stake on Randall Street, at a point two hundred (200) feet from Rutherford Street, and running thence South 1-41 West one hundred and twenty-five (125) feet to a stake; thence, South 85-39 East fifty-five (55) feet to a stake; thence, North 1-41 East one hundred and twenty-five (125) feet to a stake on the south side of Randall Street; thence, along Randall Street, North 85-39 West one hundred and twenty-five (125) feet to the beginning corner, and being the same lot conveyed to the R.B.P. Land Development Company by C.E. Bellantine on March 13, 1929, by deed recorded in Deed Book 148, page 266, R.M.C. Office for Greenville County; and deed of the said company to J.W. Norwood, Trustee by deed dated August 7, 1933, recorded in R.M.C. Office, Greenville County, in Deed Book 164, at page 382, on August 7, 1933, said land being deeded to me by J.W.
