And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than Six Hundred Ninety Seven and 75/100 Dollars in a company or companies satisfactory to the mortgagee, and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee, and that in the event that the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in The Carolina Loan & Trust Company name and reimburse it
