WHEREAS, first party is indebted to The Federal Land Bank of Columbia, a corporation created, organized and existing under and by virtue of an Act of Congress, entitled the Federal Farm Loan Act, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of *Fifteen Hundred and no/100* (\$1500.00) Dollars,

payable to the order of the second party, together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of *five (5%)* percent per annum, (or at the rate of interest fixed by Act of Congress),

the first payment on interest being due and payable on the *15th* day of *November* 19*34*, and thereafter interest being due and payable *annually*; said principal sum being due and payable in

of *Twenty 20* annual installments of *Seventy 70* Dollars, the first installment of said principal being due

and payable on the *first* day of *November* 19*35*

and thereafter the remaining installments of principal being due and payable annually until the entire principal sum and interest are paid in full, and each installment of principal and interest bearing interest from due date until paid at the highest rate authorized to be charged under the Federal Farm Loan Act, as amended; all of which and such other terms, conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW KNOW ALL MEN, that first party, in consideration of the debt evidenced by the said note, and for better securing the payment thereof to second party, and for better securing the interest thereon, and in consideration of the terms of the said note, do hereby mortgage, sell, convey, and release, in the simple and sole possession, bargain, sell, and release, in the simple and sole possession, bargain, sell, and release, unto second party, its successors and assigns, the following described lands, to-wit:

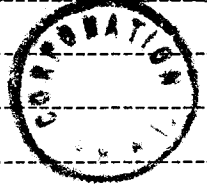
All that tract of land containing *One Hundred Five (105) acres* in *Westmoreland* Township of *Greenville* County S.C., known as the *Old Westmoreland* place, located on the *Westmoreland Road*, *fifteen (15) miles* from the *Greenville Court House*, on the waters of *Beaver Dam Creek*, bounded on the *North* by lands of *J. J. Nobles* and *A. J. Ellis*; on the *East* by lands of *J. J. Willis*; on the *South* by lands of *J. J. Nobles*; on the *West* by lands of *J. J. Nobles*, and having the following courses and distances according to survey and plat of *Ben. Martin Jr., Surveyor*:

Beginning at a stone corner of *J. J.
