All that certain piece, parcel or lot of land with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Glendale Township, at the southwest intersection of the Old Rutherford Road and Pine Avenue, and being more particularly described as follows:

"Beginning at an iron pin at the southwest intersection of the Old Rutherford Road and Pine Avenue, and running thence along the western side of said Rutherford Road, S. 14-30 W. 100 feet to an iron pin; thence N. 81-20 W. 339 feet more or less to an iron pin on the eastern side of Cherry Street; thence along the line of said Cherry Street, N. 7-15 E. 100 feet to an iron pin at the south east intersection of Cherry Street with Pine Avenue; thence along the southern side of Pine Avenue, S. 81-20 E. 339 feet more or less to the beginning corner.
