

AGREEMENT FOR EXTENSION OF LOAN NO. 16 4187-6

WHEREAS, There now remains unpaid on a certain note executed and delivered by Calista S. Cleveland  
to \_\_\_\_\_

The Prudential Life Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated December 3, 1935, recorded in said County on December 15, 1935, in Volume 171 of mortgages on Page 10, the sum of Twenty-Seven Hundred (\$2,700.00) Dollars, with interest from December 3, 1935, and,

WHEREAS, Title to the mortgaged premises is now vested in Calista S. Cleveland

subject to said mortgage, and,  
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Calista S. Cleveland

hereby agree to pay the principal sum remaining due as aforesaid as follows:

*The sum of Thirty-Three + 75/100 (\$33.75) Dollars to be paid on principal on the 3rd day of March, 1936, and a like amount on the 3rd day of June, September, December and March in each year thereafter up to and including the 3rd day of September, 1945, and the balance of the principal remaining unpaid on the 3rd day of December, 1945*

with interest thereon from December 3, 1935, to December 3, 1945, at the rate of five and one-half per cent. per annum, payable quarterly ~~annually~~ on the 3rd day of March, June, September and December in each year; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

*Privilege is given to make additional payments on the principal sum of said note in sums of One Hundred (\$100.00) Dollars or multiples thereof, on any interest maturity dates, but such additional payments shall not exceed an amount equal to one-fifth of the principal sum of the note during any twelve months period.*

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
