

AGREEMENT FOR EXTENSION OF LOAN NO. 164997-1

WHEREAS, There now remains unpaid on a certain note executed and delivered by Hattie Sansill
to

The Prudential Life Insurance Company of America, secured by a mortgage upon real estate in Greenville County,
South Carolina, dated January 5, 1936, recorded in said County on January 5, 1936,
in Volume 171 of Mortgages on Page 17, the sum of sixty four
hundred (\$6,400.00) Dollars, with interest from January 5, 1936, and,

WHEREAS, Title to the mortgaged premises is now vested in Hattie Sansill, as Trustee for
Horace A. Sansill
subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in considera-
tion of the payments to be made as herein provided.

NOW, THEREFORE, The said Hattie Sansill individually and as Trustee
for Horace A. Sansill

hereby agree to pay the principal sum remaining due as aforesaid as follows: The sum of \$160.00 to be paid
on principal on the 5th day of January 1937, and a like amount on
the 5th day of July and January in each year thereafter up to and
including the 5th day of July, 1945, and the balance of the princi-
pal remaining unpaid on the 5th day of January 1946.

with interest thereon from January 5th, 1936, to January 5th, 1946, at the rate of five (5%) per cent. per annum,
payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum
of said note in sums of \$100.00, or multiples thereof, on any interest
maturity date; but such principal payments, including obligatory
principal payments if any, called for by the terms of said note, shall
not exceed one-fifth of the original principal sum of said note during
any one year period beginning at an anniversary of said note.

And the parties to this agreement hereby consent to said extension and agree that said mortgage
shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force
except as herein modified.
