

AGREEMENT FOR EXTENSION OF LOAN NO. 309420.4

WHEREAS, There now remains unpaid on a certain note executed and delivered by Ola Gregory Querry

to _____

The Prudential Life Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated April 14, 1931, recorded in said County on April 15, 1931 in Volume 219 of Mortgages on Page 16, the sum of Four Thousand One Hundred Twenty Five (\$4,125) Dollars, with interest from April 27, 1936, and,

WHEREAS, Title to the mortgaged premises is now vested in Ola Gregory Querry

subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said Ola Gregory Querry and Du Pont Querry Jr.

hereby agree to pay the principal sum remaining due as aforesaid as follows: the sum of \$60.00 on the principal on the 27th day of July, 1936, and the sum of \$60.00 on the 27th day of October, January, April and July of each year thereafter up to and including the 27th day of January 1946, and then the balance of the principal remaining unpaid on the 27th day of April 1946.

with interest thereon from April 27, 1936, to April 27, 1946, at the rate of five (5%) per cent. per annum, payable quarter annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments on the principal sum of this note in sums of \$100, or multiples thereof, on any interest maturity date, but such principal payments, including obligatory principal payments, if any, called for by the terms of this instrument, shall not exceed one-fifth of the principal sum extended hereby during any one year period beginning at an anniversary of said note.

And the parties to this agreement hereby consent to said extension and agree that said mortgage

shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
