

AGREEMENT FOR EXTENSION OF LOAN NO. 85585-14

WHEREAS, There now remains unpaid on a certain note executed and delivered by W. N. Watson

The Prudential Life Insurance Company of America, secured by a mortgage upon real estate in Greenville County,

South Carolina, dated April 26, 1937, recorded in said County on May 2, 1937,  
in Volume 123 of Mortgages on Page 214, the sum of Eight Thousand  
and no/100 (\$8,000.00) Dollars, with interest from April 26, 1937, and,

WHEREAS, Title to the mortgaged premises is now vested in W. N. Watson

subject to said mortgage, and,  
WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in considera-  
tion of the payments to be made as herein provided.

NOW, THEREFORE, The said W. N. Watson

hereby agree to pay the principal sum remaining due as aforesaid as follows: \$2,000.00 on April 26, 1938  
\$2,000.00 on April 26, 1939, \$2,000.00 on April 26, 1940, and the  
balance of \$2,000.00 on April 26, 1941.

with interest thereon from April 26, 1937, to April 26, 1941, at the rate of four and one-half per cent. per annum,  
payable Semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:  
Privilege is given the maker of said note to make additional pay-  
ments of \$100.00 or any multiples thereof on the principal sum re-  
maining due on said note on any interest due date, provided that at  
least thirty days prior to such date, notice shall have been given in  
writing to the holder thereof of the intention to make such principal payment.

And the parties to this agreement hereby consent to said extension and agree that said mortgage  
shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force  
except as herein modified.
