

AGREEMENT FOR EXTENSION OF LOAN NO. 2762

WHEREAS, There now remains unpaid on a certain note executed and delivered by W. Lindsay Wilson,

to The Jefferson Standard Life Insurance Company
The Prudential Life Insurance Company of America, secured by a mortgage upon real estate in Greenville County,
South Carolina, dated November 10, 1941, recorded in said County on November 30, 1941,
in Volume 68 of mortgages on Page 88, the sum of Fifty-Eight Hundred
Ninety-Four (\$5,894.00) Dollars, with interest from November 10, 1941, and,

WHEREAS, Title to the mortgaged premises is now vested in The Woodside Realty Company, a
corporation chartered under the laws of the State of South
Carolina subject to said mortgage, and,

WHEREAS, The said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in considera-
tion of the payments to be made as herein provided.

NOW, THEREFORE, The said The Woodside Realty Company,

hereby agree S to pay the principal sum remaining due as aforesaid as follows:

The sum of \$176.82 to be paid on the principal on the 10th day
of May, 1945, and the sum of \$176.82 on the 10th day of November
and May of each year thereafter up to and including
the 10th day of May, 1951, and the balance on the principal
remaining unpaid on the 10th day of November, 1951,

with interest thereon from November 10, 1941, to November 10, 1951, at the rate of Five (5%) per cent. per annum,
payable Semi- annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given the borrower to pay this loan
in full on any interest payment date after the
end of the fifth year

And the parties to this agreement hereby consent to said extension and agree that said mortgage
shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force
except as herein modified.
