And the said mortgagor I agree S to insure the house, and buildings on said lot, in a sum not less than Twenty five Hundred (\$2,500.00) Dollars, and the house and buildings on lot at 207 Buncombe Street at 219 Buncombe Street, in a sum not less than Twenty five Hundred (\$2,500.00) Dollars, in a company or companies satisfactory to the mortgagee, and keep the same insured from loss or damage by fire, and assign the policy of insurance to the said mortgagee; and that in the event that the mortgagor shall at any time
