and two thousand on October 18, 1938;  
with interest thereon from the date of the first payment at the rate of 7% per annum to be  
computed and paid in arrears until paid in full; and interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time in default and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of three dollars

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell  
and release unto the said State R. McDonald,

all that piece, parcel or lots of land in Greenville Township,  
Greenville County, State of South Carolina, being known  
and designated as Lots 7, 11 and 27 of the property  
of J. J. Jenkinson, deceased, plat of said property being  
recorded in Plat Book "H" at page 207, in the R.M.C.  
Office for said county and state, reference is  
hereby made to said Plat for a more particular  
description of the above numbered lots.
