I, Susan L. Mason full Dist. Commissioner  
SEND GREETING:

WHEREAS, I, the said Susan L. Mason  
in and by my certain promissory note in writing, of  
even date with these presents, well and truly indebted to  
City View Water and Sewer Commission, Greenville, S.C.  
in the full and just sum of Eight Hundred Twenty Five (\$825.00)  
Dollars, to be paid in monthly installments of \$10.00 each beginning on the  
1st day of January, 1935 and continuing in monthly  
installments of \$10.00 each on the 1st day of each and month  
thereafter until paid in full,  
with interest thereon, from 2nd date hereof at the rate of 6 per cent. per annum to be  
computed and paid this semi-annually  
in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection or if said debt, or any part thereof,  
be collected by an attorney on legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will  
more fully appear.  
NOW, KNOW ALL MEN, That I, the said Susan L. Mason  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said  
City View Water and Sewer Commission  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said  
Susan L. Mason  
in hand well and truly paid by the said  
City View Water and Sewer Commission

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell  
and release unto the said City View Water and Sewer Commission

its successors and assigns, all those certain lots or parcels  
or land situated, lying and being in Greenville Township  
County and State aforesaid, and designated as lots nos.  
8 and 10 on plat of "White City View", recorded in R.M.C. Office  
Greenville County in Plat Book E page 116, and having, as  
a whole, the following meter and bounds:  
Beginning at an iron pin on Smith Street 150 feet from  
the Northwest corner of Smith St. and O'Neal Ave., and  
running thence 79.43 N. 184.3 feet to iron pin on a 20 foot  
alley; thence with said alley S. 06 E. 104 feet; thence S. 81.47  
E. 184.1 feet to an iron pin on Smith St.; thence with Smith St.  
N. 20 W. 111 feet to the beginning corner, and being the same  
lots of land conveyed to me by Henry P. Mc Kee by deed dated  
January 1st, 1924, recorded in R.M.C. Office for Greenville County  
in Book 99, page 180.
