with interest thereon, from Dec. 15-1934 at the rate of 6% per cent. per annum to be computed and paid annually.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent.

besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as part thereof, if the same be placed in the hands of an attorney for collection, ~~or any cost, or any part thereof,~~ be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

All that parcel or tract of land containing Eighty one and thirty six one hundredths (81 36/100) acres more or less in Highland Township County of Greenville State aforesaid lying on both sides of the surface treated road, leading from Greer to Landrum, South Carolina, and having the following courses and distances according to a survey and plat prepared by W. O. Morrow, Surveyor, dated August 20th, and 21st, 1934, to-wit

Beginning at an iron pin in the Greer-Landrum Road the northeastern corner of said tract and running thence N. 88° 20' 1.15 chs to an iron pin in road, thence S. 44-30 W. 34.20 chs to a stake, thence S. 44-30 W. 13.00 chs to a stake, thence S. 85- E. 13-40 chs to a stake, thence S. 58- E. 22.75 chs to a stake in the old Greenville and Rutherford Road, thence along said old road as follows

Thence along another road N. 55 W. 9.50 chs to an iron pin in the Greer and Landrum road, thence N. 13 W. 5.00 chs to an iron pin in said road, thence N. 17 E. 4.24 chs to an iron pin in said road thence N. 53 1/2 E. 4.50 chs to the beginning corner. The above described tract of land is the same conveyed to R. Kemp and J. H. Kemp by Deed from Berry Wilson executed Dec 29, 1890 recorded in the R. M. C. Office for Greenville County in Deed Book XX at page 395, and a small portion thereof is the same land conveyed to the said R. Kemp by S. J. Brain by deed dated Dec 2, 1922 recorded in R. M. C. Office for Greenville County in Deed Book 87 page 386.
