KNOW ALL MEN BY THESE PRESENTS: That I, J. O. Gordon, of the City of Greenville, in the
County of Greenville, in the State of South Carolina,

and hereinafter known and designated as Mortgagor, whether one or more, _____ SEND GREETINGS:

WHEREAS, the mortgagor stands indebted unto HOME OWNERS' LOAN CORPORATION, a Corporation created under Section 4 of an Act of Congress of the United States of America, known as Home Owners' Loan Act of 1938, approved June 18, 1938, with its principal place of business in the City of Washington, in the District of Columbia, in the United States of America, hereinafter known and designated mortgagee, as evidenced by a certain promissory note of even date herewith, for the full and just principal sum of _____

Four hundred ninety-seven and 59/100

Dollars (\$ 497.59), payable to the order of the mortgagee, together with interest thereon from the date at the rate of Five per centum (5%) per annum on the balance remaining from time to time unpaid; both principal and interest being payable on an amortization plan in monthly installments of Five and 29/100 Dollars

(\$ 5.29) per month on the first day of each and every month hereafter; the payments being applied, first, to interest on unpaid balances, and the remainder to principal until said debt is paid in full. Extra payments may be made on the due date of any installment, and interest will be charged only on the balance of said debt remaining unpaid. All of which, and such other terms and conditions as contained in said note, will fully appear by reference thereto; default in payment of any installment of principal and/or interest for a period of ninety (90) days to render the whole debt due at the option of the mortgagee.

NOW KNOW ALL MEN, That the mortgagor, in consideration of the said debt and the sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the terms of the said note and of this mortgage, and also in consideration of the further sum of Three Dollars (\$3.00) to the said mortgagor in hand well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold and released, in fee simple, and by these presents does grant, bargain, sell and release, in fee simple, unto the mortgagee, its successors and assigns, the following described land, to wit:

All that certain piece, parcel or lot of land, with the improvements thereon, or to be erected thereon, situate, lying and being at the Northwest corner of Nichols Street and First Avenue, in Section known as "Nickeltown", near the City of Greenville, in Greenville Township, in the County of Greenville, in the State of South Carolina, being Lot No. 5 and Nos. 5 1/2 as shown on plat of property of H. W. Hunt made by W. D. Neves, Engineer, (undated), recorded in Plat Book "C", at Page 207; being bounded as follows: On the North by Lot No. 4 1/2 now or formerly owned by J. W. Goddard, on the East by First Avenue, on the South by Nichols Street, and on the West by Lot No. 10 now or formerly owned by Walter Wright, and having the following metes and bounds, to-wit: Beginning at the Northwest corner of Nichols Street and First Avenue, and running thence with the western side of First Avenue N. 00-30 W. 93.5 feet to corner of Lot No. 4 1/2, thence with the line of said lot, S. 84-30 W. 210.5 feet to a point in line of Lot No. 10, thence with the line of said lot S. 1-20 E. 151.1 feet to Nichols Street, thence with the northern side of Nichols Street N. 68-50 E. 210 feet to the beginning corner; said premises being that conveyed to J.O. Gordon by Fannie C. Scott and J. P. Ballenger by deed dated June 3, 1927, and recorded in the R. M. C. Office for Greenville County on June 11, 1927, in Book of Deeds "124" at page 331.
