

TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises unto the said The Estate of Emma P. Baker its Executors, Administrators, Distributors and Heirs and Assigns, forever. And I do hereby bind myself and my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said premises unto the said The Estate of Emma P. Baker, its Executors, Administrators, Distributors and Heirs and Assigns, from and against myself and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same, or any part thereof.

And the said Mortgagegor agree to insure the house and buildings on said lot in a sum not less than Twenty Two Hundred (\$2200.00) Dollars (in a company or companies satisfactory to the mortgage...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagegor... and that in the event that the mortgagegor... shall at any time fail to do so, then the said mortgagegor... may cause the same to be insured in its name and reimburse itself for the premium and expenses of such insurance under this mortgage, with interest.

And if at any time any part of said debt, or interest thereon, be past due and unpaid I hereby assign the rents and profits of the above described premises to said mortgagegor... or its Heirs, Executors, Administrators or Assigns, and agree that any Judge of the Circuit Court of said State may, at chambers or otherwise, appoint a receiver with authority to take possession of said premises and collect said rents and profits, applying the net proceeds thereof (after paying costs of collection) upon the said debt, interest, costs or expenses; without liability to account for anything more than the rents and profits actually collected.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if I the said mortgagegor... do and shall well and truly pay or cause to be paid unto the said mortgagegor... the said debt, or sum of money aforesaid, with interest thereon, if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void; otherwise to remain in full force and virtue.

AND IT IS AGREED, by and between the said parties, that the said mortgagegor... is to hold and enjoy the said Premises until default of payment shall be made.
